Introductory Remarks

The index register holds information in the possession of the Javno Preduzeće Elektroprivreda BiH d.d. Sarajevo (hereinafter: Elektroprivreda BiH). Access to information in terms of the Law on Freedom of Information („Official Gazette of Federation of BiH“ No. 32/01), (hereinafter referred to as: the Law) as described in „Guide on access to information in the possession of the Javno Preduzeće Elektroprivreda Bosne i Hercegovine d.d. Sarajevo“.

Activity of Elektroprivreda BiH is the generation, distribution and supply of electricity. Elektroprivreda BiH is a single legal entity, and according to the organizational structure it is a complex system, organized according to the functional, process-work and territorial principle. It consists of the generation and distribution units.

Generation Parts of Elektroprivreda BiH:


- Hydropower plants on the rivers Neretva, Jablanica,
- Thermal Power Plant „Kakanj“, Kakanj
- Thermal Power Plant „Tuzla“, Tuzla.

Distribution Parts of Elektroprivreda BiH:

- „Elektrodistribucija“ Mostar, Mostar,
- „Elektrodistribucija“ Sarajevo, Sarajevo,
- „Elektrodistribucija“ Tuzla, Tuzla,

- number of customers and matters related to customer service, the supply of electricity and manner of regulation of mutual obligations between supplier and customers,
- investments, claims and debts,
- information in the field of environmental management,
- data concerning the legislation with which the legislator regulates the field of electrical energy,
- normative acts regulating relations in the organization,

- information about conditions for connection to the electrical system and the issuance of required approvals,
- information about takeover of electricity,
- information concerning the general conditions for supply of electricity,
- information concerning the Tariff System- tariffs and the average prices of electricity,
- information concerning the plans for construction, reconstruction and rehabilitation of power facilities.
